Of this total, (4) U.S. employees are subject to filing Form W-2 with the Internal Revenue Service, while the remaining (49) employees are required to submit their tax reports in accordance with Guatemalan regulations.**

**Form 990, Part VI, Section B, Line 11b - Prior to the online submission of Form 990, the finance team transmits the final draft via email to the Finance and Administrative Committee (FAC).
